Health Services

The health services department consists of HIV testing, STI screening, diagnosing and treatment and Transgender Health. Services are available 6 days a week during non-traditional office hours and conducts over 3,200 tests and screening of multi-site specimens. Services include risk reduction counseling, behavior modification conversations, linkage to additional physical and mental health services, referrals to accessing PEP and PrEP as well as linkage to internal programs and services. Transgender Health services include, in addition testing and screening, direct client linkage to housing, employment development, access to affirming primary care including hormone replacement therapy (HRT), and local gender affirming services and specialized medical care.
